CALL FOR PAPERS

Those aiming for June edition must submit their paper on or before 28th of April while those for December edition must submit papers on or before 31stSeptember each year.

GUIDELINES FOR AUTHORS

- 1. The manuscript should be prepared in MS-Word with Time New Romans font size 12, double line spaced and not more than 15 pages including references and appendices and tables.
- 2. The cover page should contain the title of the manuscript, author(s) full name(s) and affiliation(s), functional email addresses and telephone number(s). The cover page should indicate the correspondent author in the case of multiple authors.
- 3. The manuscript should start with an abstract of not more than 250 words clearly stating the statement of the problem, methodology, findings and recommendation/ contributions to knowledge. The abstract should be followed by a minimum of four key words and a maximum of seven.
- 4. Every manuscript will be subjected to a blind peer review and only those recommended will be published.
- 5. Authors whose manuscripts are accepted will be required to pay a processing/publication fee of fifteen thousand naira (N15, 000.00) or US\$50.
